Dear Dr. med Ulrich Werth,

I would like to inform you that I feel well after the implant-acupuncture treatment made on 20. April.

My condition improved in the first 10 days after the treatment.

For instance: In the morning, after getting up without help, most of the symptoms like toddling steps, swelling, tremor of arm and leg, motoric unrest when sitting or stiffness of the body and joints, were gone.

From 01.05.2006 my condition deteriorated more and more.

For instance: Flow of movement, swelling and motoric unrest in my legs.

Very frequently, I can't go, because I have no strengths in my legs and the symptoms with pain have recurred. Sometimes the pain is so strong that I have to take tramal.

On 29.05.2006 my condition improved slightly.

I feel that something is going on in my body. I have big hope that my condition will get better and keep on improving.

Dear Dr. Werth,

Referring to your letter of 9.6.2006 I would like to make a statement regarding the implant acupuncture conducted by you.

The treatment made was not related to Parkinson's disease.

For about 35 years I have suffered from chronic vertebral pain syndrome of cervical spine and lumbar spine including degenerative modifications accompanied by statodynamic disorders, Epicondylitis ulnaris humeri l. utr. (copied from the medical report after the treatment at a health resort).

Five years ago, after a collapse, I suffered from permanent strong pain in both elbows (golf arm). This pain could only be relieved temporarily with injections.

After the first implant acupuncture the pain abated in my neck region and elbows.

After the second treatment the pain was further relieved.

One year after the implant acupuncture, the disorders occur very rarely in lumbar spine region that abate after approximately 2 days. The painful spasms in neck region do not occur any longer. When the weather is changing, I still feel a little discomfort in elbows.

I can do housework and gardening, which were impossible before the acupuncture.

Nordic walking is also possible.

In times, when I feel little pain, I have the impression something is triggered in my mind that relieves and abates the pain.

Dear Dr. Werth,

I feel I must report about my recovery after the acupuncture.

On 29th May, 2006 I was in your practice for a Parkinson's treatment. The implants led, already at the same day, to an improvement of my language abilities.

I still took the same medication dose until the middle of June 2006 and slightly better mainly in my head and upper part of the body.

As the medication had considerable side effects on me, I started to reduce the dose, in the first week Fluctin, in the second week Amantadin.

Only after I have not taken these two pills, my digestion changed from hard stool to completely soft stool, every day, at the same time my bladder problems reduced to a bearable rate.

As a result, Stalevo 150 was reduced, which I used to take 3 times a day, to Stalevo 100 and further on to zero (0) until beginning of August. From now on, I just took one half Cabaseril at night.

At this time I felt much better, however, was afraid of a drawback, because I felt like a man with joy of life after a long hard time. From 06.08.2006 I also stopped taking Cebaseril.

My current condition, as of 20.08.2006, I would like to describe as follows:

- better mental condition
- improved mobility of arms and legs
- decreasing stiffness of legs and knees
- reduced edemas of the legs and feet
- reduced tremor at night, ringing in the ears, swallowing disorders, facial edemas were eliminated
- improved digestion and bladder function
- only few tremors of arms and left leg (only under stress)
- improved cogitation, more stamina and energy
- mainly straight posture
- enjoy eating and drinking
- enjoy reading and experiencing my environment

Every day I discover positive developments regardless my full occupation in my enterprise. In the future I will take more breaks and work only 40 hours. I realized that my body currently needs more relaxation.

I am fully aware that I am still ill, but...

I am alive again!!!
